

Spring Harvest Discount Scheme 2012

How do I apply?

To apply for your discount voucher from Spring Harvest, simply follow these steps.

New for 2012! You can either, apply for the discount first and we will reserve the appropriate allocation for you for 14 days to allow you to make your booking and send us your booking reference number – you can forward the booking confirmation later if you have chosen a paper copy. Alternatively you can make your booking first and then apply for a discount.

Please note. Funds are limited for 2012 and your application form will be returned unprocessed if insufficient funds are available. We operate on a first-come, first-served basis, and recommend early application to avoid disappointment.

- **Make your booking with Butlins**, using the appropriate telephone number (see Step 2 at the back of the brochure). If you have not yet done this, please book now. This can be done as part of a group booking.
- **Complete the reverse side of this form.**
- **Send this form** together with a photocopy of any document showing the type of benefit being claimed and a copy of your Butlins confirmation* to Spring Harvest at the address below, to be received **NO LATER THAN 31 January, 2012**. Claims for bookings made after this date should be sent in immediately and must be received by us by 20 March 2012.

* If you don't have your confirmation yet, please forward all the other documents now and then send us the confirmation as soon as it is available.

How do I complete my booking?

After you receive your discount voucher from Spring Harvest, take the following action:

- **If yours is an individual or family booking** — Please send the voucher, and your final balance of payment, to the appropriate* Administration Centre. This must reach Butlins Resort at least 56 days before your holiday commences (unless you book after 4 February, when full payment has to be made at time of booking).
- **If you are part of a group booking** — Your voucher will have been sent to your group/party organiser. Please give your final balance to them to forward, together with the voucher(s), to the appropriate* Administration Centre. This must reach Butlins Resort at least 56 days before your holiday commences (unless you book after 4 February, when full payment has to be made at time of booking).

* *Skegness* — Butlins Resort, Skegness, Lincolnshire PE25 1NJ

* *Minehead* — Butlins Resort, Minehead, Somerset TA24 5SH

The final step

The last step in the process is slightly involved — so please **read this section carefully**.

When the Administration Centre personnel receive your cheque and voucher, they process the cheque and then the voucher. The computer will sometimes generate a statement showing that an amount equivalent to your voucher(s) is still outstanding. This statement is sent to you or your group organiser — **please ignore the financial details** but check everything else for accuracy.

When this happens a further statement will be sent to you or the group organiser showing a zero balance. Note: If you book after 4 February you will have made full payment so you should send the discount voucher to the resort, which will then send you a cheque for that amount.
